### Schedule P Significant Accounting Policies And Notes Forming part of The Financial Statements For the year ended March 31, 2023

### 1. Method of Accounting

The accounts have been prepared under the historical cost convention on going concern basis following the accrual and double entry system of accounting, except where specified otherwise. Accounting policies not specifically referred to otherwise, are consistent and in consonance with generally accepted accounting principles including expenditure as capital or revenue. All accounting policies followed are consistent with those followed in the previous year including transfer to funds etc., except where specifically mentioned.

### 2. Use of Estimates

The presentation of the financial statements is in conformity with the generally accepted accounting principles, which require the management to make estimates, and assumptions that affect the reported amount of assets and liabilities, revenue and expenses and disclosure of contingent liabilities. Such estimates and assumptions are based on management's evaluation of relevant facts and circumstances as on the date of financial statements. The actual outcome may diverge from these estimates. All estimates are consistent with those followed in the previous year.

### 3. Revenue Recognition

The accounts have been maintained on mercantile basis, except in the case of membership fees, in respect of which, the accounting in the books is on receipt basis.

### 4. <u>Presentation of Incomes and Expenses in the Financial Statements</u>

The incomes / expenses shown in the Income and Expenditure Account are net of the expenses / incomes in case of Permit Room, Guest Room & Premises Income/Expenses.

### 5. Inventories

The inventories are valued at lower of cost or realizable value.

Due to lock-down due to Covid-19 pandemic, inventory amounting to Rs.1,66,620 /-was in Stock on 31st March,2023 but expired. The Said Stock can be removed/destroyed only after following the process with consent of State Excise Department. However, since the said expired stock is not realizable, it's not consider in the inventory Value.

### 6. Fixed Assets

The fixed assets are stated at cost less depreciation.



The Club has maintained a Fixed Assets Register. The management is planning for physical verification of the fixed assets and also for its reconciliation with the updated book records.

### 7. Depreciation

Depreciation on fixed assets has been provided on written down value basis at the rates prescribed under the Income Tax Rules, 1962 except for premium on leasehold land, which is amortized on straight-line basis over the period of lease as per the Agreement.

### 8. Investments

Investments are stated at cost and are held in the name of the Club.

### 9. Regrouping of Financial Statements' Items

Previous year figures have been regrouped / rearranged/ recast, wherever necessary. Further, all figures have been rounded-off to the nearest rupee.

### 10. Contribution to Charity Commissioner

In view of a decision of the Honorable Mumbai High Court granting stay on collection of contribution by the Office of the Charity Commissioner, no provision has been made in accounts relating to the said contribution. Contribution payable, if any, will be accounted for as and when paid.

### 11. Maintenance and Classification of Membership Records

The membership records maintained by the Club are not in consonance with the respective amounts reflected in the accounts. A Membership Reconciliation Committee has been constituted by the General Body in its meeting held on 11th Dec 2011 and the said committee is in the process of reconciliation of the same.

### 12. Provisions

A provision is recognized when there is present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are determined based on best estimate of the amount required to settle the obligation at the balance sheet date.

Please also refer Note on Contingent Liabilities.

### 13. Contingent Liabilities

- (a) There is a Bank Guarantee of Rs. 2.55 Crores with Bank of India which is submitted to MCGM connection with construction of School Building;
- (b) The Club had demand notice dated 12th March, 2019 for Rs. 53.65 Crores from MHADA for allegedly breach of one condition laid down in the Lease agreement dated 18th March, 2004 between MHADA and Mig Cricket Club;



- (c) The Club has challenged the above notice and the demand raised by MHADA by filling writ petition (L.) No.18592 of 2022 before the Hon'ble High Court, Bombay, challenging inter alia impugned communication dated 07-Jun-2022 wherein the MHADA had threaten to take over the land of the club on 15-Jun-2022 due to non-construction of the school as per the original lease deed and has also demanded Rs.53.65 Crores as and by way of 'fine' along with interest towards alleged construction cost;
- (d) The Hon'ble High Court vide its order dated 15-Jun-2022 in Writ Petition (L.)No.18592 of 2022 was pleased to grant ad-interim stay to the order seeking possession from petitioner (MIG Cricket Club) on a condition that the petitioner (MIG Cricket Club) shall deposit an amount of Rs.15 Crores within a period of four weeks from the date of the order.
- (e) In view of the order dated 15-Jun-2022 passed in Writ Petition (L.)No.18592 of 2022, the Club has deposited an amount of Rs.15. Crores with the Prothonotary and Senior Master, High Court, Bombay(Mumbai).
- (f) The Club is contesting few cases of Income-Tax assessment (s)/appeal(s)/demand/allegations(s) (gist of which is given herein).
- (g) As per management estimates, there is no financial damage likely to the Club due to any of these contingencies, though outcome of those are very uncertain provision of any amount in the accounts is not considered necessary.
  - Please also refer Note on Provisions.

### (B) Notes - I Tax Assessments etc.s

- a) An appeal has been filed by the Income Tax Department challenging the order of the CIT(A) [Commissioner of Income Tax - Appeals] for A.Y.2008-09. It is pertinent to note that our assessments up to A.Y.2007-08 have been completed allowing exemption u/s.11.The appeal filed by the Income Tax Department was dismissed by the Hon'ble Income Tax Appellate Tribunal (ITAT) on the basis of orders of the jurisdictional High Court in the club's own case.
- b) Section 12A registration of the club had been cancelled by the Commissioner of Income Tax (Exemptions). As a consequence the Assessing Officer completed the assessment for A.Y.2009-10 assessing the club as a mutual concern and denying the exemption u/s.11.CIT(A) upheld the action of the Assessing Officer. The club preferred appeals before ITAT in respect of both- Cancellation of registration u/s.12A and denial of exemption

u/s.11 for A.Y.2009-10.In the combined order passed by ITAT, it restored the issue regarding registration u/s.12A back to the file of the CIT (Exemptions).It also restored the matter relating to denial of exemption u/s 11 for A.Y.2009-10 to the file Assessing Officer for de novo adjudication in the light of fresh decision to be passed by CIT (Exemptions). The CIT (Exemptions) restored the registration with retrospective effect by an order dated 18-Apr-2018. The Assessing Officer however, in the de novo assessment denied the exemption on the ground that the activities carried out by the club are commercial in nature and assessed the club as mutual concern. The appeal filed before CIT(a) is pending adjudication.

- c) The Assessments for A.Y.2010-11 to A.Y.2013-14 were completed assessing the club as a mutual concern and as a corollary; the exemption was denied and tax demands raised. The CIT (A) confirmed the orders of the assessing officer and did not grant any relief. The club preferred appeals to Hon'ble ITAT. Hon'ble ITAT restored the matters to the file of the assessing officer, to consider the claims of the club de novo. The assessments for A.Y.2010-11 to A.Y.2013-14, are therefore pending before the assessing officer.
- d) The Return filed for A.Y.2014-15 was treated invalid on account of the fact that defect therein (Non filing of Form 10B) was not cured within the stipulated time as the financials were not finalized and audited. The Centralized Processing Centre (CPC) processed the return denying exemption and determined certain tax payable. The club preferred an appeal against the action of the CPC. Written submissions have been made before CIT (A) under the faceless appeal scheme. The order of CIT(A) is awaited.
- e) Assessment for A.Y.2015-16 was completed treating the Club as an unregistered trust since registration u/s.12A was cancelled and is assessed accordingly. An Appeal was filed against the said order, before the CIT(A). The CIT(A) dismissed the appeal for non-compliance with the hearing notices. The said notices were not received by the club on its designated email id and hence compliance could not be made. The club has filed an appeal against the order passed by the CIT(A) before the Hon'ble Income Tax Appellate Tribunal which is pending adjudication.
- f) The club filed its return of income for A.Y.2016-17, claiming exemption u/s.11.An intimation from CPC, Bangaloreis received for A.Y.2016-17 (Dated30-May-2018) determining full refund of TDS and taxes paid by accepting the return. The refund ascertained along with interest is adjusted by the Income Tax Department against the disputed tax demands for earlier years.
- g) The club filed its return of income for A.Y.2017-18 claiming exemption u/s.11 The case was selected for scrutiny and the assessing officer denied exemption. The club has filed an appeal with CIT(A) which is pending adjudication.



- h) The return of income for A.Y.2018-19 was filed claiming exemption u/s.11.An intimation u/s.143(1) from CPC was received where the income is accepted as per the return filed. The refund ascertained of Rs.1,02,28,985/-(including interest of Rs.5,09,372/-) is adjusted by the Income Tax Department against the pending disputed demands.
- i) The return of income for A.Y.2019-20 was filed claiming exemption u/s.11.An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.46,84,324/- (including interest of Rs.1,80,164/-) was ascertained. The said refund amount along with interest is adjusted by the Income Tax Department against the pending disputed demands.
- j) The return of income for A.Y.2020-21 was filed on 14-Feb-2021 on the basis of provisional accounts under the directions of Managing Committee, to protect the interests of the club to the extent possible. The said return was processed by the CPC and exemption was denied for non-filing of statutory form. The intimation was not received on the designated email id of the club and hence the appeal could not be filed in time. The club is in the process of filing an appeal before the learned CIT(A) against the said intimation.
- k) The return of income for A.Y.2021-22 was filed on 14-Mar-2022 claiming exemption u/s 11. An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.28,06,880/- (including interest of Rs.2,07,912/-) was ascertained. The said refund amount along with interest is adjusted by the Income Tax Department against the pending disputed demands.
- i) The revised return of income for A.Y.2022-23 was filed on 28-Dec-2022 claiming exemption u/s 11. An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.1,85,814/-(including interest of Rs. NIL/-) was ascertained.
- m) By virtue of amendmend in the Income Tax Act by the Taxation and Other Laws (Relaxation and Amendment of Certain Provisions) Act,2020, wef. 01-Apr-2021, a trust already registered u/s.12A was also obligated to file an application for reregistration on or before 30-Jun-2021. The said date was extended from time to time. In pursuance of the said amendment and time extension, the Club has applied for registration u/s.12A(1) (ac) of the Act on 28-Mar-2022 and has been granted registration u/s.12AB on 05-Apr-2022 for five years commencing from A.Y.2022-23.
- n) The Club believes that since its registration under section 12A, has been restored, it is eligible for exemption under section 11. Consequently in regard to appeals pending adjudication, and the assessments pending before the assessing officer, no provision is considered necessary.



### 15. Carrying Cost of Assets

In opinion of the Managing Committee, all assets other than fixed assets and noncurrent investments have a realizable value in the ordinary course of business, which is not less than the amount at which they are stated in the financial statements. However, the balances of current assets, loans and advances are subject to verification and external confirmations. Also that:

A) Financial/ Revenue impact of Memberships offered by Mumbai Cricket Association (MCA) couldn't be ascertained: The MCA had allotted memberships for its MCA Recreation Centre at BKC, for its Garware Club House at Churchgate and for its MCA Club at Kandivali to its various affiliated clubs. MCA had given discretion to its member clubs to nominate individuals for these memberships. M.I.G. Cricket Club (MiG.CC) was allotted the following memberships:

B) (i) Amount receivable from Trustee: During previous years, amounts aggregating to Rs. 2.81.000 had been advanced to one of the then Trustees. Mr. Pravin Barve towards expenses. Apparently, since explanations in that regard had not been furnished, the same had been disclosed as "Receivable from Trustee" in the Balance Sheet as on 31st March, 2011. The General Body of the Club, in the Annual General Meeting held on 11th December, 2011, has authorized the Board of Trustees to look into the complaint of 41D filed against Mr. Pravin Barve. The matter has been addressed by a Committee appointed by Board of Trustees to review the application u/s 41D read with 41E against Mr. Pravin Barve which has duly submitted its findings to the Board of Trustees. This matter along with the findings were discussed in the AGM and it was resolved that the same may be treated as prior period expenses. The entries to this effect was to be passed in the subsequent Balance Sheet. Meanwhile the Joint Charity Commissioner passed an order for the complaint u/sec 41D on 23/11/2015; an enquiry has been started on the said issue by the office of Charity Commissioner. Consequently, no action has been taken on the resolution passed by the general body on the matter of



waiving the amount due from Mr. Pravin Barve. Depending on the outcome of the inquiry, if any amount is deemed payable by Mr. Pravin Barve, interest will be charged and accounted for in the year in which the decision is received from the office of the Charity Commissioner.

(ii) There are certain balances bought forward from the Audited Balance Sheet of 31st March, 2019, amounting to Rs. 38,98,641/-, which need to be reconciled and appropriate accounting entries need to be passed. The Managing Committee has taken up the said activity and appropriate effects will be given in the books of accounts as Prior Period Adjustments. The account wise break-up of the said amounts is as follows:

## Schedule P Significant Accounting Policies and Notes Forming part of The Financial Statements For the year ended March 31, 2024

### 1. Method of Accounting

The accounts have been prepared under the historical cost convention on going concern basis following the accrual and double entry system of accounting, except where specified otherwise. Accounting policies not specifically referred to otherwise, are consistent and in consonance with generally accepted accounting principles including expenditure as capital or revenue. All accounting policies followed are consistent with those followed in the previous year including transfer to funds etc., except where specifically mentioned.

### 2. Use of Estimates

The presentation of the financial statements is in conformity with the generally accepted accounting principles, which require the management to make estimates, and assumptions that affect the reported amount of assets and liabilities, revenue and expenses and disclosure of contingent liabilities. Such estimates and assumptions are based on management's evaluation of relevant facts and circumstances as on the date of financial statements. The actual outcome may diverge from these estimates. All estimates are consistent with those followed in the previous year.

### 3. Revenue Recognition

The accounts have been maintained on mercantile basis, except in the case of membership fees, in respect of which, the accounting in the books is on receipt basis.

### 4. <u>Presentation of Incomes and Expenses in the Financial Statements</u>

The incomes / expenses shown in the Income and Expenditure Account are net of the expenses / incomes in case of Permit Room, Guest Room & Premises Income/Expenses.

### 5. Inventories

The inventories are valued at lower of cost or realizable value.

Due to lock-down due to Covid-19 pandemic, inventory amounting to Rs.1,66,620 /-was in Stock on 31st March,2024 but expired. The Said Stock can be removed/destroyed only after following the process with consent of State Excise Department. However, since the said expired stock is not realizable, it's not consider in the inventory Value.



### 6. Fixed Assets

The fixed assets are stated at cost less depreciation.

The Club has maintained a Fixed Assets Register. The management is planning for physical verification of the fixed assets and also for its reconciliation with the up-dated book records.

### 7. Depreciation

Depreciation on fixed assets has been provided on written down value basis at the rates prescribed under the Income Tax Rules, 1962 except for premium on leasehold land, which is amortized on straight-line basis over the period of lease as per the Agreement.

### 8. Investments

Investments are stated at cost and are held in the name of the Club.

### 9. Regrouping of Financial Statements' Items

Previous year figures have been regrouped / rearranged/ recast, wherever necessary. Further, all figures have been rounded-off to the nearest rupee.

### 10. Contribution to Charity Commissioner

In view of a decision of the Honorable Mumbai High Court granting stay on collection of contribution by the Office of the Charity Commissioner, no provision has been made in accounts relating to the said contribution. Contribution payable, if any, will be accounted for as and when paid.

### 11. Maintenance and Classification of Membership Records

The membership records maintained by the Club are not in consonance with the respective amounts reflected in the accounts. A Membership Reconciliation Committee has been constituted by the General Body in its meeting held on 11th Dec 2011 and the said committee is in the process of reconciliation of the same.

### 12. Provisions

A provision is recognized when there is present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are determined based on best estimate of the amount required to settle the obligation at the balance sheet date.

Please also refer Note on Contingent Liabilities.

### 13. Contingent Liabilities

(a) There is a Bank Guarantee of Rs. 2.55 Crores with Bank of India which is submitted to MCGM connection with construction of School Building;



- (b) The Club had a demand notice dated 12th March, 2019 for Rs.53.65 Crores from MHADA for allegedly breach of one condition laid down in the Lease agreement dated 18th March, 2004 between MHADA and Mig Cricket Club;
- (c) The Club has challenged the above notice and the demand raised by MHADA by filling writ petition (L.) No.18592 of 2022 before the Hon'ble High Court, Bombay, challenging inter alia impugned communication dated 07-Jun-2022 wherein the MHADA had threaten to take over the land of the club on 15-Jun-2022 due to non-construction of the school as per the original lease deed and has also demanded Rs.53.65 Crores as and by way of 'fine' along with interest towards alleged construction cost;
- (d) The Hon'ble High Court vide its order dated 15-Jun-2022 in Writ Petition (L.)No.18592 of 2022 was pleased to grant ad-interim stay to the order seeking possession from petitioner (MIG Cricket Club) on a condition that the petitioner (MIG Cricket Club) shall deposit an amount of Rs.15 Crores within a period of four weeks from the date of the order.
- (e) In view of the order dated 15-Jun-2022 passed in Writ Petition (L.)No.18592 of 2022, the Club has deposited an amount of Rs.15.Crores with the Prothonotary and Senior Master, High Court, Bombay(Mumbai).
- (f) The Club is contesting few cases of Income-Tax assessment (s)/appeal (s)/demand/allegations(s) (gist of which is given herein).
- (g) As per management estimates, there is no financial damage likely to the Club due to any of these contingencies, though outcome of those are very uncertainprovision of any amount in the accounts is not considered necessary.
  - Please also refer Note on Provisions.
- (h) The employees union agreement with Shramik Utkarsha Sabha was valid till March, 2023. Their charter of demands has been received and the management is negotiating with Shramik Utkarsha Sabha for the renewal of the same. The changes in the salary arrears of all staff on the role due to the revised charter of demands is not provided and the same is not ascertainable.

- allowing exemption u/s.11.The appeal filed by the Income Tax Department was dismissed by the Hon'ble Income Tax Appellate Tribunal (ITAT) on the basis of orders of the jurisdictional High Court in the club's own case.
- b) Section 12A registration of the club had been cancelled by the Commissioner of Income Tax (Exemptions). As a consequence the Assessing Officer completed the assessment for A.Y.2009-10 assessing the club as a mutual concern and denying the exemption u/s.11.CIT(A) upheld the action of the Assessing Officer. The club preferred appeals before ITAT in respect of both- Cancellation of registration u/s.12A and denial of exemption u/s.11 for A.Y.2009-10.In the combined order passed by ITAT, it restored the issue regarding registration u/s.12A back to the file of the CIT (Exemptions).It also restored the matter relating to denial of exemption u/s 11 for A.Y.2009-10 to the file Assessing Officer for de novo adjudication in the light of fresh decision to be passed by CIT (Exemptions). The CIT (Exemptions) restored the registration with retrospective effect by an order dated 18-Apr-2018. The Assessing Officer however, in the de novo assessment denied the exemption on the ground that the activities carried out by the club are commercial in nature and assessed the club as mutual concern. The appeal filed before CIT(a) is pending adjudication.
- c) The Assessments for A.Y.2010-11 to A.Y.2013-14 were completed assessing the club as a mutual concern and as a corollary; the exemption was denied and tax demands raised. The CIT (A) confirmed the orders of the assessing officer and did not grant any relief. The club preferred appeals to Hon'ble ITAT. Hon'ble ITAT restored the matters to the file of the assessing officer, to consider the claims of the club de novo. Out of these four years, the Club has received Assessment Orders for AY 2011-12 and AY 2012-13 in favor of the Club. The assessments for A.Y.2010-11 and A.Y.2013-14 are pending before the assessing officer.
- d) The Return filed for A.Y.2014-15 was treated invalid on account of the fact that defect therein (Non - filing of Form 10B) was not cured within the stipulated time as the financials were not finalized and audited. The Centralized Processing Centre (CPC) processed the return denying exemption and determined certain tax payable. The club preferred an appeal against the action of the CPC. Written submissions have been made before CIT (A) under the faceless appeal scheme. The order of CIT(A) is awaited.
- e) Assessment for A.Y.2015-16 was completed treating the Club as an unregistered trust since registration u/s.12A was cancelled and is assessed accordingly. An Appeal was filed against the said order, before the CIT(A). The CIT(A) dismissed the appeal for non-compliance with the hearing notices. The said notices were not received by the club on its designated email id and hence compliance could not be made. The club has filed an appeal against the order passed by the CIT(A)



before the Hon'ble Income Tax Appellate Tribunal. ITAT has set aside the CIT(A) order and restored the Appeal.

- f) The club filed its return of income for A.Y.2016-17, claiming exemption u/s.11.An intimation from CPC, Bangaloreis received for A.Y.2016-17 (Dated 30-May-2018) determining full refund of TDS and taxes paid by accepting the return. The refund ascertained along with interest is adjusted by the Income Tax Department against the disputed tax demands for earlier years.
- g) The club filed its return of income for A.Y.2017-18 claiming exemption u/s.11 The case was selected for scrutiny and the assessing officer denied exemption. The club has filed an appeal with CIT(A) which is pending adjudication.
- h) The return of income for A.Y.2018-19 was filed claiming exemption u/s.11.An intimation u/s.143(1) from CPC was received where the income is accepted as per the return filed. The refund ascertained of Rs.1,02,28,985/- (including interest of Rs.5,09,372/-) is adjusted by the Income Tax Department against the pending disputed demands.
- i) The return of income for A.Y.2019-20 was filed claiming exemption u/s.11.An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.46,84,324/- (including interest of Rs.1,80,164/-) was ascertained. The said refund amount along with interest is adjusted by the Income Tax Department against the pending disputed demands.
- j) The return of income for A.Y.2020-21 was filed on 14-Feb-2021 on the basis of provisional accounts under the directions of Managing Committee, to protect the interests of the club to the extent possible. The said return was processed by the CPC and exemption was denied for non-filing of statutory form. The intimation was not received on the designated email id of the club and hence the appeal could not be filed in time. The club has filed an appeal before the learned CIT(A) against the said intimation.
- k) The return of income for A.Y.2021-22 was filed on 14-Mar-2022 claiming exemption u/s 11. An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.28,06,880/- (including interest of Rs.2,07,912/-) was ascertained. The said refund amount along with interest is adjusted by the Income Tax Department against the pending disputed demands
- The revised return of income for A.Y.2022-23 was filed on 28-Dec-2022 claiming exemption u/s 11. An intimation u/s.143(1) from CPC was received where the income is accepted as per Income Tax Return filed and a refund of Rs.1,85,814/-(including interest of Rs.NIL/-) was ascertained. The said refund amount along



with interest is adjusted by the Income Tax Department against the pending disputed demands.

- m) By virtue of amendment in the Income Tax Act by the Taxation and Other Laws (Relaxation and Amendment of Certain Provisions) Act,2020, wef.01-Apr-2021, a trust already registered u/s.12A was also obligated to file an application for reregistration on or before 30-Jun-2021. The said date was extended from time to time. In pursuance of the said amendment and time extension, the Club has applied for registration u/s.12A(1) (ac) of the Act on 28-Mar-2022 and has been granted registration u/s.12AB on 05-Apr-2022 for five years commencing from A.Y.2022-23.
- n) The Club believes that since its registration under section 12A, has been restored, it is eligible for exemption under section 11. Consequently in regard to appeals pending adjudication, and the assessments pending before the assessing officer, no provision is considered necessary.

### 15. Carrying Cost of Assets

In opinion of the Managing Committee, all assets other than fixed assets and noncurrent investments have a realizable value in the ordinary course of business, which is not less than the amount at which they are stated in the financial statements. However, the balances of current assets, loans and advances are subject to verification and external confirmations. Also that:

A) Financial/ Revenue impact of Memberships offered by Mumbai Cricket Association (MCA) couldn't be ascertained: The MCA had allotted memberships for its MCA Recreation Centre at BKC, for its Garware Club House at Churchgate and for its MCA Club at Kandivali to its various affiliated clubs. MCA had given discretion to its member clubs to nominate individuals for these memberships. M.I.G. Cricket Club (MiG.CC) was allotted the following memberships:

- Amount receivable from Trustee: During previous years, amounts aggregating to B) (i) Rs. 2,81,000 had been advanced to one of the then Trustees, Mr. Pravin Barve towards expenses. Apparently, since explanations in that regard had not been furnished, the same had been disclosed as "Receivable from Trustee" in the Balance Sheet as on 31st March, 2011. The General Body of the Club, in the Annual General Meeting held on 11th December, 2011, has authorized the Board of Trustees to look into the complaint of 41D filed against Mr. Pravin Barve. The matter has been addressed by a Committee appointed by Board of Trustees to review the application u/s 41D read with 41E against Mr. Pravin Barve which has duly submitted its findings to the Board of Trustees. This matter along with the findings were discussed in the AGM and it was resolved that the same may be treated as prior period expenses. The entries to this effect was to be passed in the subsequent Balance Sheet. Meanwhile the Joint Charity Commissioner passed an order for the complaint u/sec 41D on 23/11/2015; an enquiry has been started on the said issue by the office of Charity Commissioner. Consequently, no action has been taken on the resolution passed by the general body on the matter of waiving the amount due from Mr. Pravin Barve. Depending on the outcome of the inquiry, if any amount is deemed payable by Mr. Pravin Barve, interest will be charged and accounted for in the year in which the decision is received from the office of the Charity Commissioner.
  - (ii) There are certain balances bought forward from the Audited Balance Sheet of 31st March, 2019, amounting to Rs. 42,32,337/-, which need to be reconciled and appropriate accounting entries need to be passed. The Managing Committee has taken up the said activity and appropriate effects will be given in the books of accounts as Prior Period Adjustments. The account wise break-up of the said amounts is as follows:
