- (i) Notice and provisional list of members eligible to vote will be put up on the Notice Board by Saturday 24<sup>th</sup> May 2025.
- (ii) Members having any suggestions, objections or corrections to the list may write to the Returning Officer before 27<sup>th</sup> May 2025.
- (iii) The final list of members eligible to vote will be available in the Club Office on 29th May 2025.
- (iv) The nominations in the prescribed format, duly proposed and seconded and signed by the candidates, will be accepted in the office of the Club or by the Returning Officer from 30<sup>th</sup> May 2025 to 5<sup>th</sup> June 2025 between 2.00 P.M. to 7.00 P.M. on working days.
- (v) The received Nomination forms will be scrutinized by the Returning Officer and the list of eligible candidates to contest the election will be put up on the Notice Board on 07<sup>th</sup> June, 2025.
- (vi) The withdrawal of the nomination has to be made in writing before 7:00 P.M. on 8th June 2025.
- (vii) The final list of members eligible to contest will be put up on the Notice Board on 11<sup>th</sup> June 2025.
- (viii) The members eligible to vote shall elect 14 members from the Patron/Life /Ordinary member's constituency.

## Note:

- 1) Only Patron/Life/Ordinary members above the age of 25 years and not attained 68 years of age and who have completed a minimum of two years from the date of their admission prior to the date of the Notice of the Election shall be eligible to CONTEST the election.
- 2) Only Patron/Life/Ordinary members, who have completed a minimum of one year from the date of their admission to the date of notice, shall have the right to VOTE in the election.
- 3) Only Patron/Life/Ordinary members who have completed two years of membership before the date of Notice of Election shall have the right to PROPOSE/SECOND the candidature in the election.
- 4) Members who are defaulters shall not be eligible to contest the election for the Managing Committee and propose or second the nominee.
- 5) Members who are suspended or undergoing suspension shall not be eligible to vote and contest the election for the Managing Committee and propose or second the nominee.
- 6) Members should carry their membership cards at the time of polling.
- 7) Posting Notice of the Biennial Election of the Managing Committee on the Notice Board of the Club shall be construed as the official notice for the election and non-receipt of Notice by any member shall not invalidate the proceedings of the Elections.
