The 52<sup>nd</sup> Annual Report provides comprehensive details of the activities, initiatives, and achievements across all departments. I am pleased to share that we are successfully moving forward with renewed energy.

MIG Cricket Club is committed to preserving its proud legacy while embracing innovation, inclusivity, and excellence in sports, fitness, and community engagement. Our vision is to nurture talent, provide facilities, and create a vibrant platform that promotes cricket, all sports, fosters cultural enrichment, and strengthens bonds among members.

On 15<sup>th</sup> August 2025, MIG Cricket Club inaugurated its newly renovated Gym, furthering our commitment to health and wellness. The upgraded gym is equipped with modern facilities and was inaugurated by Chief Guest Ms. Jemimah Rodrigues, with Guests of Honor Dr. Ajit Desai and Mr. Karan Veer Mehra marking an important milestone for the Club.

We successfully completed a major Wi-Fi and IT infrastructure upgrade, replacing old hardware with new D-Link equipment, installing a Sophos firewall for enhanced security, and upgrading our internet lease line from 50 Mbps to 150 Mbps. This ensures seamless connectivity and an enhanced digital experience for both members and staff.

Plans have been initiated to renovate the Cloud9 Bar and the Ground & First Floor lobbies. The bar expansion will increase seating from 100 to 160+ and introduce modern design elements while retaining the Club's classic charm, have an open see-through wall, and a Trophy Wall that celebrates MIGCC's sporting heritage.

In line with our vision to diversify sporting opportunities, we are also introducing Pickleball – one of the fastest-growing sports worldwide – into our facilities. This addition will encourage wider participation across age groups, promote fitness, and provide members with another engaging recreational option beyond cricket and other established sports.



The Diwali edition of the Panorama Magazine was released on 18<sup>th</sup> October 2025, showcasing club activities, member achievements, and highlights of recent events. This continues to strengthen the sense of community and keep members informed and engaged.

The year 2024–2025 was marked by notable achievements for MIG Cricket Club. The Cricket team won the 2024-25 President Cup and the Dr. H. D. Kanga Cricket League we were Runners- Up. # **Sports Report 2024-25**

#### **CRICKET**

# MIG Cricket Club - Summary of Work Completed Projects and Infrastructure Development Dept.

MIG Cricket Club has recently completed a comprehensive series of renovation and modernization projects aimed at enhancing member comfort, safety, and the overall Club experience.

Significant upgrades were made to the infrastructure and safety systems, including a revamped fire-fighting network with advanced smoke, gas, and fire alarm detectors, installation of emergency panic buttons on all floors, and the introduction of a Blue Code emergency response system. A new gas-fired hot water boiler and a replacement hydropneumatic tank now ensure improved water and utility performance, supported by upgraded Wi-Fi and firewall systems.

Major renovations include the complete refurbishment of all member washrooms, Health Club, and Table Tennis Room, alongside extensive repairs to the swimming pool filtration plant. The beautification drive covered all 22 guest rooms, Galaxy Hall, Polestar Venue, and the Coffee Shop, featuring fresh paintwork, lighting, furniture, and decor enhancements.

As part of ongoing development, the Club is transformed its gymnasium and Health Club which is ongoing into a state-of-the-art Spa Centre.

Also as a part of ongoing development, the Club is transforming its Cloud 9 Bar and Lobbies, reaffirming MIG Cricket Club's commitment to provide best facilities for its members.



# Schedule Q Significant Accounting Policies and Notes forming part of The Financial Statements for the Year Ended March 31, 2025

## 1. Method of Accounting

The accounts have been prepared under the historical cost convention on going concern basis following the accrual and double entry system of accounting, except where specified otherwise. Accounting policies not specifically referred to otherwise, are consistent and in consonance with generally accepted accounting principles including expenditure as capital or revenue. All accounting policies followed are consistent with those followed in the previous year including transfer to funds etc., except where specifically mentioned.

## 2. Use of Estimates

The presentation of the financial statements is in conformity with the generally accepted accounting principles, which require the management to make estimates, and assumptions that affect the reported amount of assets and liabilities, revenue and expenses and disclosure of contingent liabilities. Such estimates and assumptions are based on management's evaluation of relevant facts and circumstances as on the date of financial statements. The actual outcome may diverge from these estimates. All estimates are consistent with those followed in the previous year.

# 3. Revenue Recognition

The accounts have been maintained on mercantile basis, except in the case of membership fees, in respect of which, the accounting in the books is on receipt basis.

# 4. Presentation of Incomes and Expenses in the Financial Statements

The incomes / expenses shown in the Income and Expenditure Account are net of the expenses / incomes in case of Permit Room, Guest Room & Premises Income/Expenses.

#### 5. Inventories

The inventories are valued at lower of cost or realizable value.

Due to lock-down due to Covid-19 pandemic, inventory amounting to Rs.1,66,620 /-was in Stock on 31st March, 2025 but expired. The Said Stock can be removed/destroyed only after following the process with consent of State Excise Department. The Club is constantly following up with the said department. However, since the said expired stock is not realizable, it's not consider in the inventory Value.



## 6. Fixed Assets

The fixed assets are stated at cost less depreciation.

The Club has maintained a Fixed Assets Register. The management is planning for physical verification of the fixed assets and also for its reconciliation with the up-dated book records.

# 7. Depreciation

Depreciation on fixed assets has been provided on written down value basis at the rates prescribed under the Income Tax Rules, 1962 except for premium on leasehold land, which is amortized on straight-line basis over the period of lease as per the Agreement.

#### 8. Investments

Investments are stated at cost and are held in the name of the Club.

# 9. Regrouping of Financial Statements' Items

Previous year figures have been regrouped / rearranged/ recast, wherever necessary. Further, all figures have been rounded-off to the nearest rupee.

# 10. Contribution to Charity Commissioner

In view of a decision of the Honorable Mumbai High Court granting stay on collection of contribution by the Office of the Charity Commissioner, no provision has been made in accounts relating to the said contribution. Contribution payable, if any, will be accounted for as and when paid.

# 11. Maintenance and Classification of Membership Records

The membership records maintained by the Club are not in consonance with the respective amounts reflected in the accounts. A Membership Reconciliation Committee has been constituted by the General Body in its meeting held on 11th Dec 2011 and the said committee is in the process of reconciliation of the same.

#### 12. Provisions

A provision is recognized when there is present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are determined based on best estimate of the amount required to settle the obligation at the balance sheet date.

Please also refer Note on Contingent Liabilities.



# 13. Contingent Liabilities

- (a) There is a Bank Guarantee of Rs.2.55 Crores with Bank of India which is submitted to MCGM connection with construction of School Building;
- (b) The Club had a demand notice dated 12th March, 2019 for Rs. 53.65 Crores from MHADA for allegedly breach of one condition laid down in the Lease agreement dated 18th March, 2004 between MHADA and MIG Cricket Club;
- (c) The Club has challenged the above notice and the demand raised by MHADA by filling writ petition (L.) No.18592 of 2022 before the Hon'ble High Court, Bombay, challenging inter alia impugned communication dated 07-Jun-2022 wherein the MHADA had threaten to take over the land of the club on 15-Jun-2022 due to non-construction of the school as per the original lease deed and has also demanded Rs.53.65 Crores as and by way of 'fine' along with interest towards alleged construction cost;
- (d) The Hon'ble High Court vide its order dated 15-Jun-2022 in Writ Petition (L) No.18592 of 2022 was pleased to grant ad-interim stay to the order seeking possession from petitioner (MIG Cricket Club) on a condition that the petitioner (MIG Cricket Club) shall deposit an amount of Rs.15 Crores within a period of four weeks from the date of the order.
- (e) In view of the order dated 15-Jun-2022 passed in Writ Petition (L.) No.18592 of 2022, the Club has deposited an amount of Rs.15.Crores with the Prothonotary and Senior Master, High Court, Bombay(Mumbai).
- (f) The Club is contesting few cases of Income-Tax assessment(s)/appeal(s) /demand/allegations(s) (gist of which is given herein).
- (g) As per management estimates, there is no financial damage likely to the Club due to any of these contingencies, though outcome of those are very uncertain provision of any amount in the accounts is not considered necessary.
  - Please also refer Note on Provisions.
- 14. The Club has received a sum committed as a donation from members to whom the MCA membership is issued through Parel Sporting Club and Friends Sport Club (total amounting to Rs. 1,64,00,000/-). The said amount is deposited in Fixed Deposit with Banks on 20-5-2025, since the amount is received subject to an undertaking given to MCA that in the event of decision of the court being adverse to the Club; the Club shall be liable to refund the entire sum so received. Apart from the above, the Club has also received donation from members to whom the MCA membership is issued through MIGCC and Star Sports Club.



#### 15. Information related to the Income-tax Assessments, etc.

Section 12A registration of the club had been cancelled by the Commissioner of Income Tax (Exemptions) ("CIT(E)") on 29th December, 2011. The Club preferred appeal before Income Tax Appellate Tribunal (ITAT) against the said order. ITAT restored the matter to the file of CIT(E) for fresh examination. The CIT(E) restored the registration with retrospective effect by his order dated 18th April, 2018.

Pursuant to restoration of registration by CIT(E), ITAT restored the matter for five years to the file of the Assessing Officer for de novo adjudication. Out of these five years, the assessment for two years have been completed granting the exemption to the club. Assessment order has not been received for two years and in respect of one year, the assessing officer denied the exemption and the matter is pending before the Commissioner of Income Tax (Appeals) ("CIT(A)"). Apart from the above five years, in case of AY 2017-18 the regular assessment was completed without taking the cognizance of the restoration of registration and hence the exemption was denied. The club has filed an appeal before the CIT(A) which is pending adjudication.

In respect of one year, where the appeal was pending before the CIT(A), the club did not receive notices of hearing on its designated email id and could not therefore respond to the notices. The CIT(A) therefore passed an ex-parte order denying the exemption. The appeal was filed before the ITAT and the matter was restored to the file of CIT(A) for adjudication on merits by order dated 4th December, 2023. Similarly, in respect of one year where the assessment was completed on best-judgment basis for similar reason, the appeal was filed before the CIT(A) who restored the matter to the Assessing Officer. Notices of hearing have not been received from the CIT(A) and Assessing Officer respectively.

In respect of two years, the exemption was denied to the club while processing the return for non-submission of statutory audit report before the specified date. In one year the club filed a condonation application before CIT(E) who condoned the delay and granted the exemption. In other year, the appeal was preferred before CIT(A) who dismissed the appeal and the club has preferred an appeal before ITAT.

For six years, the returns filed by the club claiming exemption have been processed and have been accepted and refund determined. The club, however, did not receive these refunds as the same have been adjusted against the disputed demands for other years. Amount of aggregate refunds (including interest) which has been adjusted against disputed demands is Rs. 2,49,03,177/- which is reflected in schedule G.

By virtue of amendment in the Income Tax Act, a trust already registered u/s.12A was also obligated to file an application for re-registration and the Club applied for



re-registration u/s.12A(1)(ac) of the Act which has been granted on 05-Apr-2022 for five years commencing from A.Y.2022-23.

# 16. Carrying Cost of Assets

In opinion of the Managing Committee, all assets other than fixed assets and noncurrent investments have a realizable value in the ordinary course of business, which is not less than the amount at which they are stated in the financial statements. However, the balances of current assets, loans and advances are subject to verification and external confirmations. Also that:

- Amount receivable from Trustee: During previous years, amounts aggregating to Rs. 2,81,000 had been advanced to one of the then Trustees, Mr. Prayin Barve towards expenses, Apparently, since explanations in that regard had not been furnished, the same had been disclosed as "Receivable from Trustee" in the Balance Sheet as on 31st March, 2011. The General Body of the Club, in the Annual General Meeting held on 11th December, 2011, has authorized the Board of Trustees to look into the complaint of 41D filed against Mr. Pravin Barve. The matter has been addressed by a Committee appointed by Board of Trustees to review the application u/s 41D read with 41E against Mr. Pravin Barve which has duly submitted its findings to the Board of Trustees. This matter along with the findings were discussed in the AGM and it was resolved that the same may be treated as prior period expenses. The entries to this effect was to be passed in the subsequent Balance Sheet. Meanwhile the Joint Charity Commissioner passed an order for the complaint u/sec 41D on 23/11/2015; an enquiry has been started on the said issue by the office of Charity Commissioner. Consequently, no action has been taken on the resolution passed by the general body on the matter of waiving the amount due from Mr. Pravin Barve. Depending on the outcome of the inquiry, if any amount is deemed payable by Mr. Pravin Barve, interest will be charged and accounted for in the year in which the decision is received from the office of the Charity Commissioner.
  - (ii) There are certain balances bought forward from the Audited Balance Sheet of 31st March, 2019, amounting to Rs. 42,19,660/-, which need to be reconciled and appropriate accounting entries need to be passed. The Managing Committee has taken up the said activity and appropriate effects will be given in the books of accounts as Prior Period Adjustments. The account wise break-up of the said amounts is as follows:
